A Meeting of Sacred Waters 2024 is a global gathering for sharing Indigenous worldviews, values and perspectives to reclaim the health of the world's water sources. By coming together as a global community, we can begin to integrate health equity outcomes with critical climate responses in ways that are sustainable, systemic and transformative.

A Meeting of Sacred Waters aims to create connections, build relationships and ignite new ideas for healing our ancestral waters.

We will:

- Highlight the interconnectedness between the wellbeing of humanity and the environment.
- Share examples of Indigenous-led guardianship, stewardship and management practices.
- Provide a space to engage, exchange and explore new ideas.
- Explore pathways to heal our ancestral waters through Indigenous-led systems change.

Through the experiences of Indigenous Peoples from the US and abroad, this global exchange brings 500+ leaders together to explore solutions to restore balance for the wellbeing of humanity and the environment.

Terms of Agreement
